LIFE Programme in Spain

The LIFE Programme is the EU's funding instrument for environment and climate action. It has been running since 1992 and has co-financed more than 6 000 projects across the EU and in neighbouring countries. LIFE has contributed almost €8 billion to these projects, amounting to around two-thirds of the projects' overall budget of €12 billion. The LIFE Programme contributes directly to the objectives and targets of the European Green Deal.

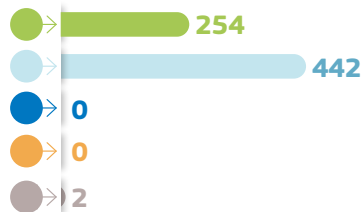

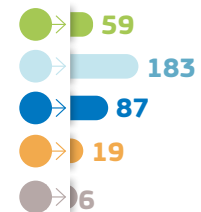

FOCUS ON 2023-2024

LIFE NATURE & BIODIVERSITY

The Nature and Biodiversity sub-programme aims to protect and restore Europe’s nature and to halt and reverse biodiversity loss. The subprogramme contributes to the implementation of the EU Birds and Habitats directives, the development and management of the Natura 2000 network, the Invasive Alien Species Regulation, and supports the achievement of the objectives of the EU Biodiversity strategy for 2030 and the newly adopted EU Nature Restoration Regulation.

Examples of ongoing projects in Spain

Loggerhead turtles particularly, a priority species in the EU Habitat Directive, face serious risks from fishing gear, which causes entanglement. **LIFE OASIS** tackles these challenges by collaborating with fisheries across the Balearic Islands, Sicily, Tunisia and Malta to test a new technology that minimises turtle bycatch. This initiative also engages local fishers in recovering entangled turtles and collecting data, helping to support the Mediterranean’s ecological health and advance international efforts to address illegal and unregulated fishing. Through cross-border collaboration, LIFE OASIS aims to create a replicable model that supports both marine conservation and sustainable fishing practices.

Invasive alien species (IAS), the second largest driver of biodiversity loss after habitat destruction, pose a severe threat to ecosystems worldwide. Cortaderia selloana, or pampas grass, exemplifies this in the Atlantic Arc, where its spread disrupts both natural and human landscapes. The LIFE **Coop Cortaderia** project combats this by controlling and eradicating the plant across 1 000 hectares in Spain and Portugal. The project will engage 250 entities in a transnational alliance, enhance governance, and train over 800 professionals. It includes public outreach, scientific knowledge sharing, and pilot eradication actions, ultimately contributing to long-term, sustainable control strategies for this invasive species.



Improving environmental conservation by increasing the efficiency and effectiveness of actions against environmental crime (Life+ Nature Guardians)

Devastating environmental crimes threaten our ecosystems, demanding urgent action to support law enforcement. The Nature Guardians project intervened by training over 1,500 agents in Spain and beyond, and producing the first Police Investigation Manual for biodiversity crimes in multiple languages.

The objective was clear: fewer animal deaths from illegal activities. By providing specialised training and innovative tools, the initiative empowered authorities to effectively combat environmental offenses.

The Nature Guardians project has generated a remarkable 62% reduction in wildlife mortality due to illegal acts, a 110% increase in crime detections and a 34.5% rise in prosecutions.

The Circular Economy and Quality of LIFE sub-programme aims to facilitate the transition toward a sustainable, circular, toxic-free, energy-efficient and climate-resilient economy and to protect, restore and improve the quality of the environment. The sub-programme mainly supports implementing innovative and best practice solutions, in particular with regard to the circular economy, including recovery of resources from waste, water, air, noise, soil and chemical management as well as environmental governance and the and the new European Bauhaus. Priority is given to solutions that are ready to be implemented in close-to-market conditions, at industrial or commercial scale.

Desalination for Environmental Sustainability And LIFE (DESALIFE)

The six project partners will validate a new zero-emissions desalination technology that uses off-shore wave-powered buoys. The buoys will use wave energy to carry out reverse osmosis of seawater and pump the resulting freshwater to shore. A small fleet of buoys will be deployed off the coast of Gran Canaria, Canary Islands, Spain, to deliver 1.7 billion litres of water.

Examples of ongoing projects in Spain

The consortium behind **LIFE NEEVE** targets the reduction of non-exhaust emissions (NEE), such as particulate matter and microplastics, from vehicles and road surfaces. These emissions, largely from tyres, brakes and pavements, have a significant impact on air quality and human health. By developing real-time onboard monitoring systems and innovative technologies, the project will reduce NEE emissions in Spain and Germany. It will also promote regulatory changes and raise awareness among manufacturers, policymakers and drivers to ensure widespread adoption of these solutions across the EU, ultimately enhancing sustainability and health outcomes for EU citizens.

The textile industry is a major contributor to environmental degradation, causing immense waste, high water consumption and substantial carbon emissions. In 2020, it generated 92 million tonnes of waste, consumed 93 billion m³ of water, and emitted 1.7 billion tonnes of CO₂. Despite growing recycling efforts, less than 50% of discarded textiles are collected for reuse, and only 1% are recycled into new clothing. The **LIFE POLITEX** project aims to address these challenges by pioneering fibre-to-fibre polyester recycling technology. This innovative process will close the loop on polyester production, turning textile waste into new fibres and promoting a more sustainable, circular textile economy. By expanding this technology, the project will reduce waste, cut emissions and establish a fully circular model for the industry.

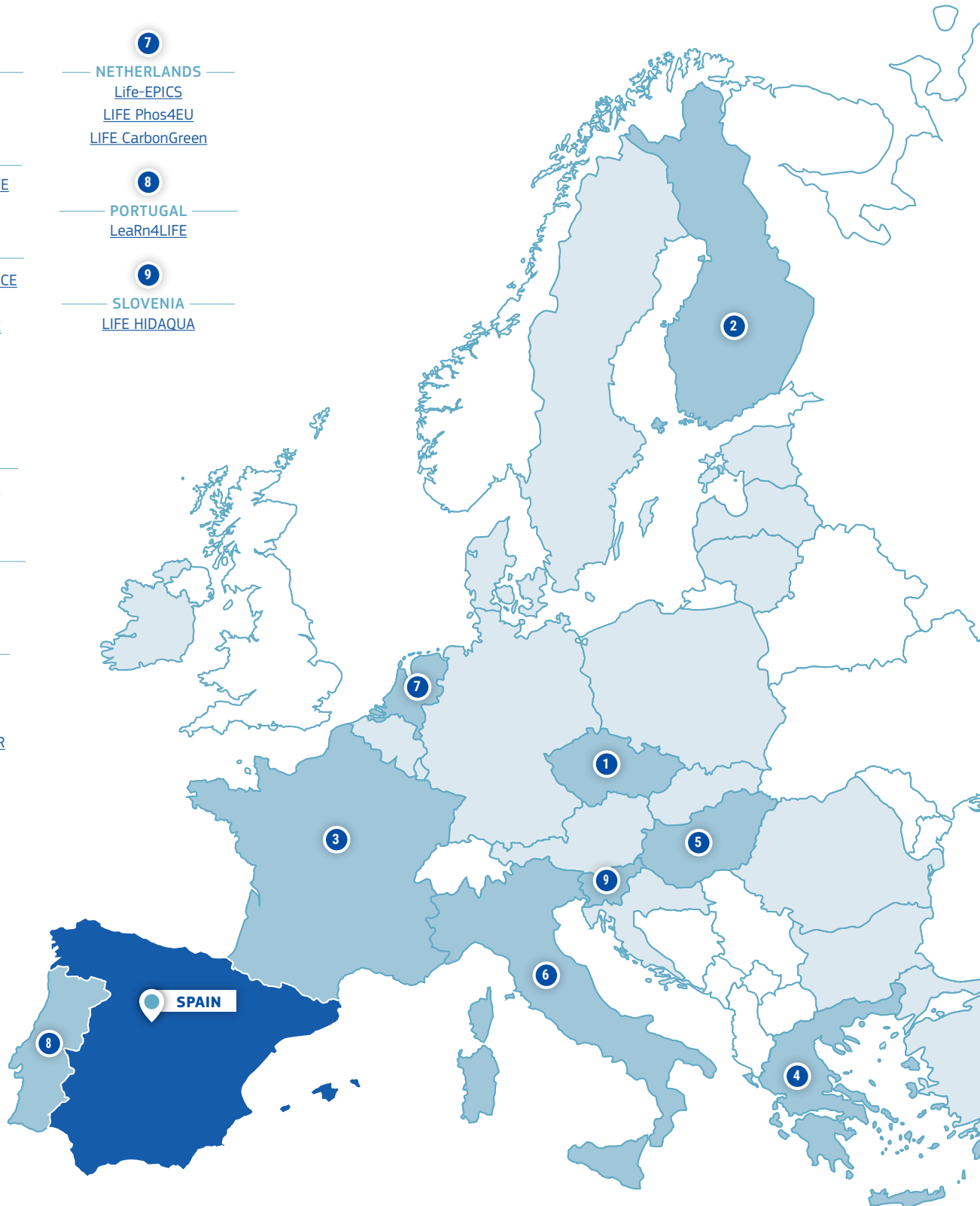

LIFE CLIMATE CHANGE MITIGATION & ADAPTATION

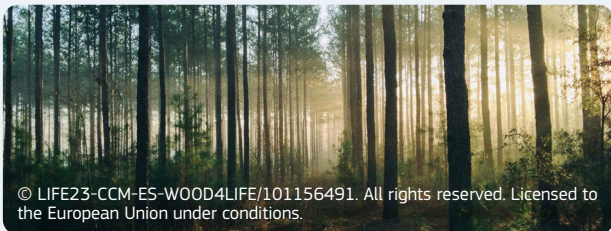

Locking carbon in harvested wood products, from forests to sustainable wood products (WOOD4LIFE)

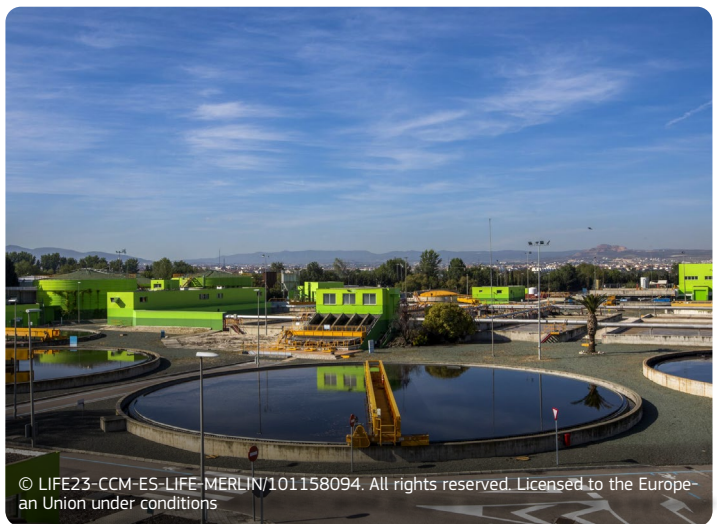
Forests play a crucial role in mitigating climate change by absorbing CO₂ and providing essential ecosystem services. However, issues such as forest abandonment, low-value wood supply chains, and lack of sustainable management practices are undermining their ability to contribute effectively to carbon sequestration. LIFE WOOD4LIFE addresses these challenges by focusing on improving forest management practices in Castilla-La Mancha, with the aim of enhancing carbon storage in soils and biomass. The project promotes the use of wood in long-lasting products like those in the construction sector, ensuring carbon remains stored outside the forest for extended periods. Through partnerships and improved business models, WOOD4LIFE strengthens the forest value chain, increasing its resilience to climate change while fostering biodiversity conservation and sustainable economic development. This initiative has the potential for replication across Europe, contributing to the EU’s broader climate goals.

Examples of ongoing projects in Spain

The **LIFE MERLIN** project focuses on increasing biogas production by using new techniques to treat waste materials more effectively. By breaking down sludge with ultrasound and combining it with other waste materials, the project aims to produce more biogas while reducing waste disposal. Tested in 2 Spanish wastewater treatment plants, it will help improve energy independence, create jobs, and reduce CO₂ emissions, supporting the EU’s decarbonisation goals.

LIFE CHANDELIER aims to boost biomethane production, a sustainable alternative to fossil fuels, in rural areas by converting agri-food waste, like olive pomace and cereal straw, into vehicle fuel. The project focuses on small, cost-effective plants that improve biogas production through innovative methods. By cutting greenhouse gas emissions by up to 80%, it promotes sustainable transport and offers a model that can be expanded to other regions, supporting the EU’s climate goals.

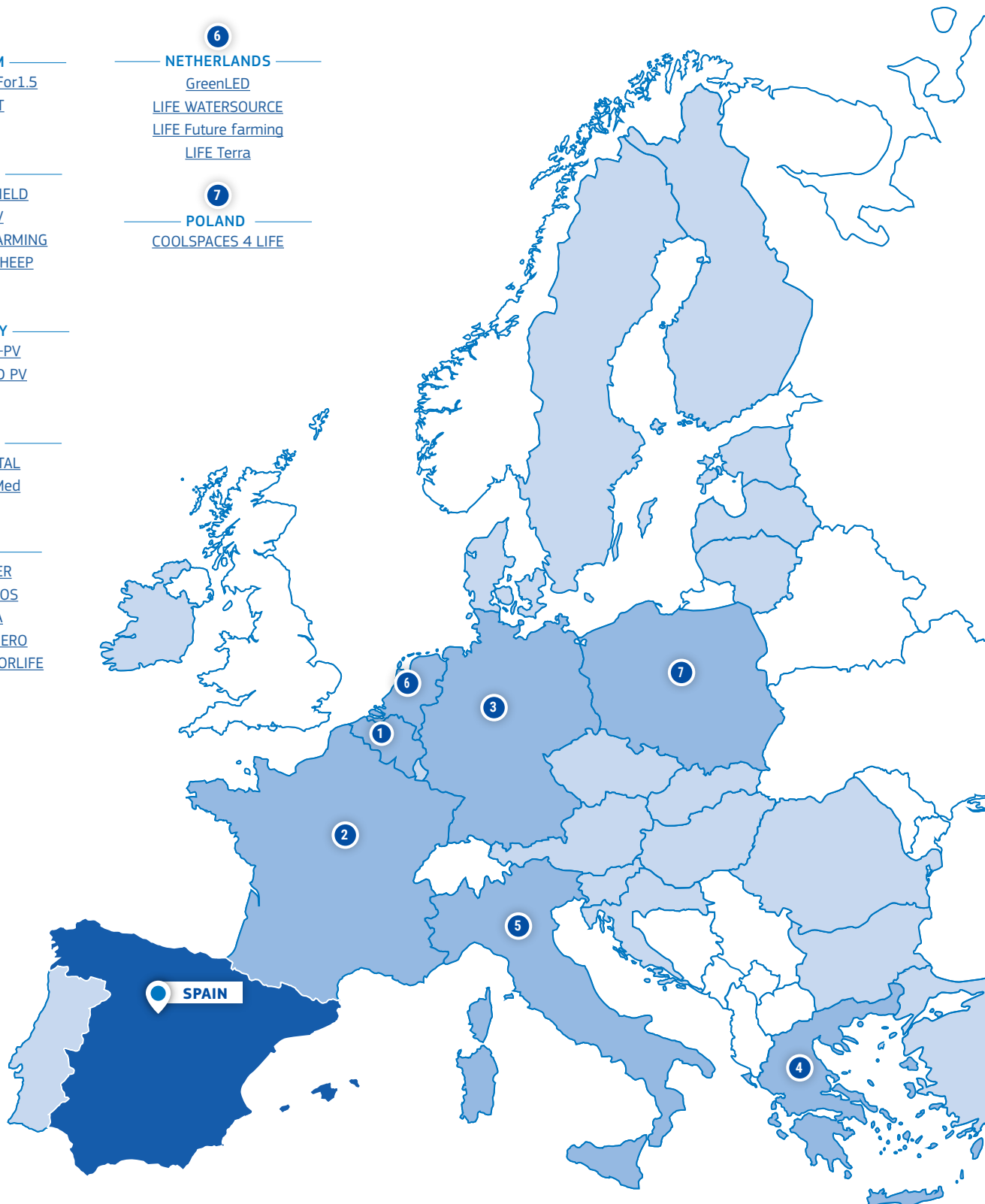

LIFE CLEAN ENERGY TRANSITION

The LIFE Clean Energy Transition sub-programme supports the delivery of EU policies in the field of sustainable energy, in particular, the European Green Deal, the Energy Union (2030 energy and climate targets) and the European Union's 2050 long-term decarbonisation strategy. It aims to facilitate the transition towards an energy-efficient, renewable energy-based, climate-neutral and -resilient economy by funding actions of high EU added-value, which are targeted at breaking market barriers that hamper the transition to sustainable energy.

Facilitating Ambitious Energy Renovation of Public Buildings through Integrated Services in Spain (FACILITA)

LIFE FACILITA tackles the challenge of energy-inefficient public buildings in Spain, which hinder the EU's clean energy goals. With low renovation rates across the country's varied climates, many local and regional authorities struggle to implement effective energy upgrades. To address this, the project's team will establish regional One-Stop-Shops (OSSs) in Extremadura, Madrid and Valencia. Each OSS will provide local and regional authorities with a full range of support services, including technical, financial and legal guidance, as well as help with procurement and quality assurance, making it easier to plan and complete building upgrades. FACILITA's approach includes analysing current legal, regulatory and financial frameworks, then tailoring each OSS to the unique needs of each region, taking climate, local government structure and economic conditions into account. After a testing phase, FACILITA will produce a toolkit for replication across other EU regions, encouraging broader policy adoption.

Examples of ongoing projects in Spain

The **ENERGIZE+** project seeks to create renewable energy communities in industrial parks across Europe, reducing CO₂ emissions and fostering sustainable practices in high-emission sectors. By developing cooperative energy models, the project team will provide training, resources and digital tools for industry stakeholders, aiming for significant renewable energy adoption and greenhouse gas reductions in 4 pilot regions. ENERGIZE+ will also serve as a scalable model for Europe's industrial energy transition goals.

RENPOWER aims to enhance home energy efficiency by establishing community-led, integrated renovation services for private homeowners in Spain and Ireland. Through local energy cooperatives, the project team will offer one-stop-shop support to guide households through energy upgrades, reducing energy consumption and emissions. A replication toolkit will also be developed, enabling other EU regions to adopt similar services and contribute to the EU's clean energy transition and climate goals. Focusing on vulnerable communities, RENPOWER targets 200 renovations and €6.8 million in investment

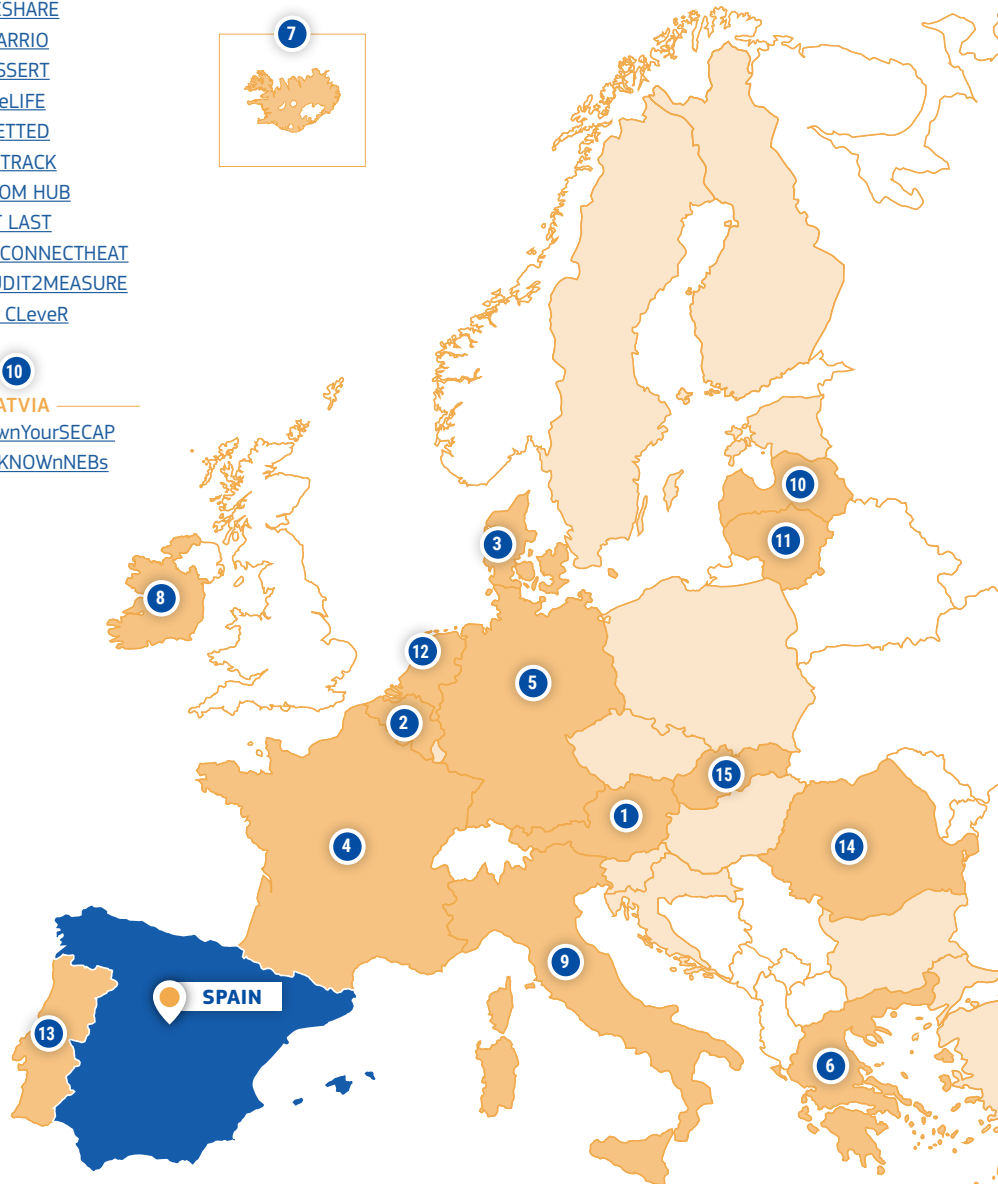

Oceana in Europe SGA 2024 (**Oceana in Europe**)

Oceana in Europe is a 2024 initiative focused exclusively on ocean conservation. It takes a strategic, science-driven approach to enforce and strengthen EU ocean policies, aiming for measurable results in sustainable fisheries, plastic pollution reduction and marine biodiversity protection. Key priorities include ensuring proper management of Europe's fisheries, reducing single-use plastics in oceans, tackling illegal and unreported fishing, and expanding the network of effective Marine Protected Areas (MPAs). Through partnerships with NGOs, EU bodies, and public awareness efforts, Oceana seeks impactful, long-lasting ocean health improvements across Europe.
