LIFE Programme in Italy

The LIFE Programme is the EU's funding instrument for environment and climate action. It has been running since 1992 and has co-financed more than 6 000 projects across the EU and in neighbouring countries. LIFE has contributed almost €8 billion to these projects, amounting to around two-thirds of the projects' overall budget of €12 billion. The LIFE Programme contributes directly to the objectives and targets of the European Green Deal.

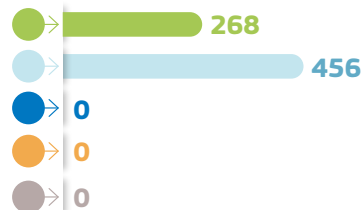

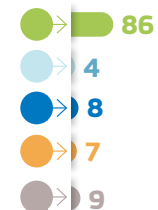

FOCUS ON 2023-2024

LIFE NATURE & BIODIVERSITY

The Nature and Biodiversity sub-programme aims to protect and restore Europe's nature and to halt and reverse biodiversity loss. The subprogramme contributes to the implementation of the EU Birds and Habitats directives, the development and management of the Natura 2000 network, the Invasive Alien Species Regulation, and supports the achievement of the objectives of the EU Biodiversity strategy for 2030 and the newly adopted EU Nature Restoration Regulation.

Fostering the settlement of Bonelli's eagle population in Sardinia (Life Abilas)

> [Project summary](#)

Bonelli's Eagle (also known as Aquila fasciata) is a protected species that is the object of the Life Abilas project. Its aim is to build on the progresses made by previous efforts so far and establish a sustainable breeding population of Bonelli's Eagles in Sardinia by continuing to release 8-10 individuals annually, while also tackling the primary conservation challenges facing the species through various activities, such as securing power lines, increasing food availability and obtaining safe living conditions for the species. Dissemination of knowledge about economic value of the species for the environment and on conservation measures to foster its breeding is also envisaged. Lastly, two murals featuring the Bonelli's Eagle will be realised by local art institutes in highly visible areas of Sardinia, with the aim to promote the image of the Bonelli's eagle and to increase in the communities of Sardinia the pride for its extraordinary naturalistic heritage, and consequently the willingness to protect it.

Examples of ongoing projects in Italy

Marine Deep Reefs are vital habitats that act as CO₂ sinks and support diverse fauna. Marine litter can harm deep reefs, causing loss of ecological functions. The **LIFE DREAM** project aims to reduce human impacts on deep reefs and promote their protection, recovery and preservation. It is implementing active measures to help deep reef regeneration, and is intended to provide fundamental data to extend the Natura 2000 network to the deep-sea by combining biological and spatial information. Restoration efforts will involve both deploying artificial structures and removing marine litter.

LIFE GREEN4BLUE targets habitat fragmentation and degradation and biodiversity reduction in the Po River valley of the Italian provinces of Bologna and Ferrara, one of the most endangered territories in terms of biodiversity conservation. In particular, LIFE GREEN4BLUE seeks to lessen the fragmentation of canal aquatic and hydrophilic ecosystems by implementing intelligent canal management practices. The project will establish a unique land management system that combines hydraulic safety, biodiversity and landscape protection. Through sustainable vegetation management of the canals, it will also enhance plant and animal biodiversity in the surrounding inner freshwater wetlands.

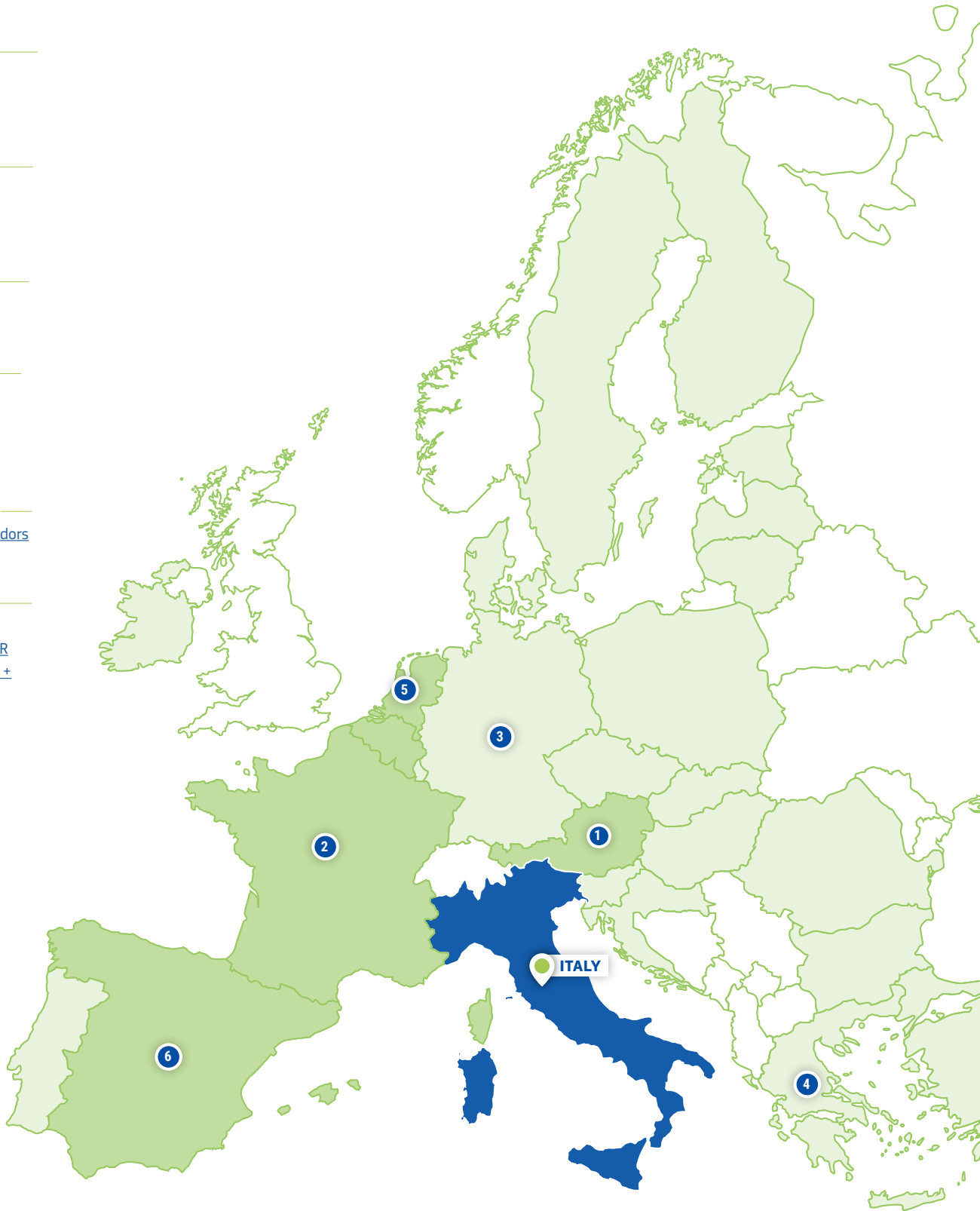

The Circular Economy and Quality of LIFE sub-programme aims to facilitate the transition toward a sustainable, circular, toxic-free, energy-efficient and climate-resilient economy and to protect, restore and improve the quality of the environment. The sub-programme mainly supports implementing innovative and best practice solutions, in particular with regard to the circular economy, including recovery of resources from waste, water, air, noise, soil and chemical management as well as environmental governance and the and the new European Bauhaus. Priority is given to solutions that are ready to be implemented in close-to-market conditions, at industrial or commercial scale.

Buildings and Education in Wood Ecosystem for the New European Bauhaus (LIFE BE WoodEN)

> [Project summary](#)

LIFE BE WoodEN sets out to improve the decarbonisation of buildings with a circular economy approach relying on wood and bio-based materials from local supply chains. Fully embracing the New European Bauhaus spirit, the project focuses on social housing for the elderly and fragile people. LIFE BE WoodEN also involves a capacity building component targeting professionals, technicians and building managers, in an effort to support the uptake of circular economy practices in building renovations. Lastly, the creation of a novel New European Bauhaus Pioneer Hub is expected to contribute to knowledge sharing and exchanges of best practices across the whole EU.

Examples of ongoing projects in Italy

Grapes are a fundamental fruit crop for Mediterranean countries' economies, and are subject to treatment with copper-based chemicals to avoid fungal diseases. Excessive use of these fungicides, however, severely impairs the soil of vineyards and the risk of copper penetration in fruits is high. The **NATURA AGRO** project tackles this issue through the development of copper-free plant protection products that can prevent common diseases while not having a deleterious environmental impact. Furthermore, the deployment of circular economy models by the project will encourage the reuse of biomass residues produced by vineyards.

The construction sector has huge potential for the adoption of circular economy principles, especially for construction and demolition waste (CDW). The **LIFE CDW CIRCLE** project deploys an innovative sorting technique to separate inert fractions of CDW to then reuse them in the construction sector, enhancing the creation of a sustainable supply chain and business practice. The creation of a CDW recycling plant in the Brescia area in Italy will also be designed and constructed by the project's partners.

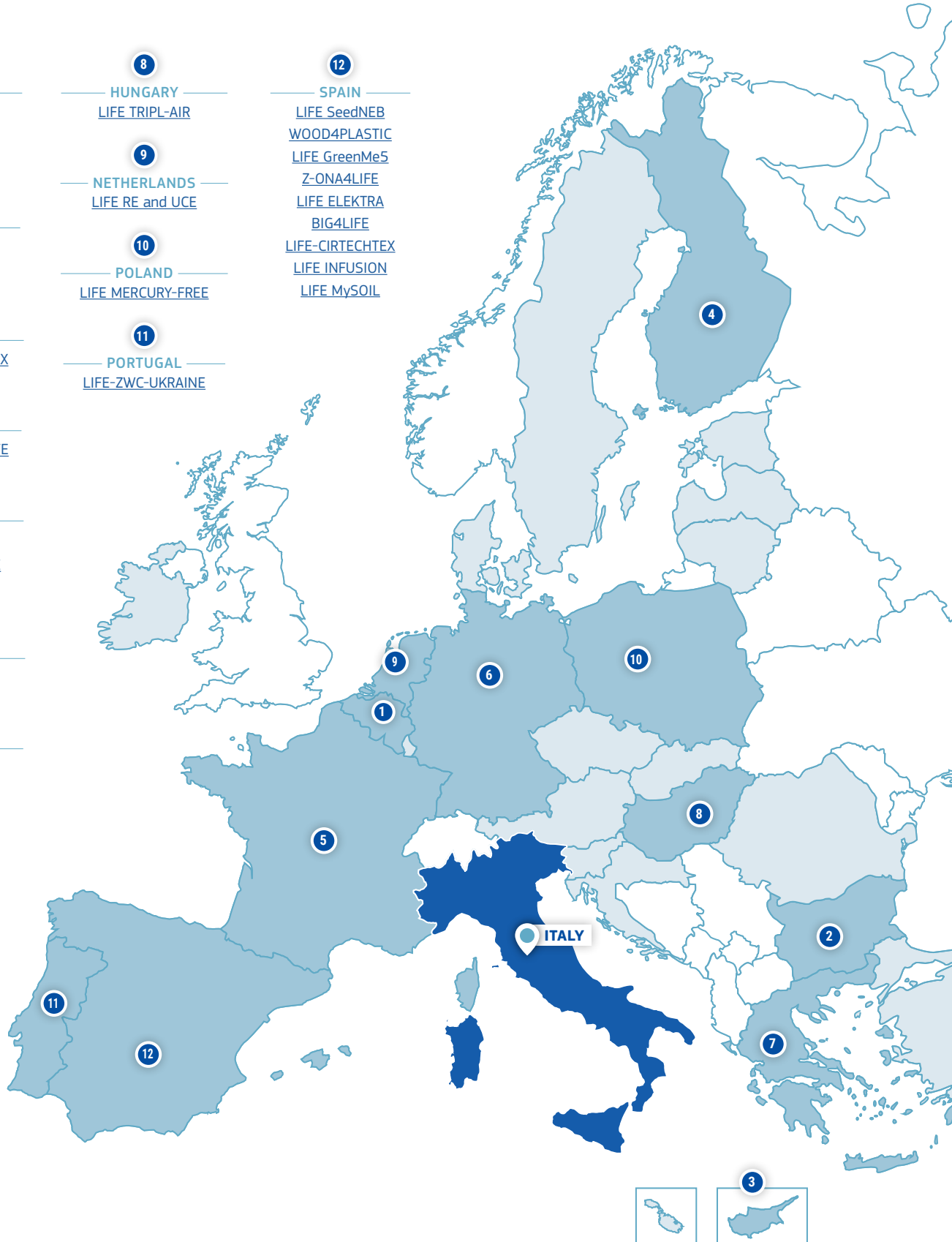

Projects under this strand contribute to the shift towards a sustainable, energy-efficient, renewable-energy-based, climate-neutral and climate-resilient economy.

Examples of ongoing projects in Italy

The Marche and Abruzzo regions in Italy have a very low Climate Vulnerability Index ratings and addressing challenges in these areas is therefore essential. The **Life + A GreenNet** project seeks to implement climate change adaptation measures to combat rising temperature and heat waves in urban areas. The project’s objectives are to create green infrastructures with the help of simulation and forecast models, to enhance the conservation of forests and green spaces through partnerships and collaborations with stakeholders, and to encourage the uptake of green infrastructure to lower surface temperatures.

Transportation is responsible for nearly half of all CO₂ emissions in South Tyrol in Italy. The **Zero Emission LIFE IP** project concerns the development of a zero-emission road transport and mobility system across and beyond the region. This will be achieved through the uptake of zero-emission vehicles in regional and municipal services and public transport, the spread of green fuelling and charging stations, and the development and implementation of low-carbon footprint packages to foster eco-tourism.



Improving the resilience of pArmiGiano rEggiano supply chain - LIFE (IMAGE LIFE)

Climate change poses a serious threat to appropriate growing of maize crops, which require high water consumption and are prone to aflatoxin contamination. Parmigiano Reggiano cheese supply chain has maize as main cereal component of the feed. The IMAGE LIFE project seeks to implement resilient agricultural principles to achieve sustainable cultivation of water saving crops for the production of Parmigiano Reggiano. Among the purported objectives, the replacement of maize with sorghum and consequent reduction of dependence on maize grain imports and the optimisation of the sorghum-based feed ration is the most prominent. The landmark achievement of the project is the combination of agricultural and animal sciences with socio-economic expertise and technological advancements for one of Italy’s most important dairy products.

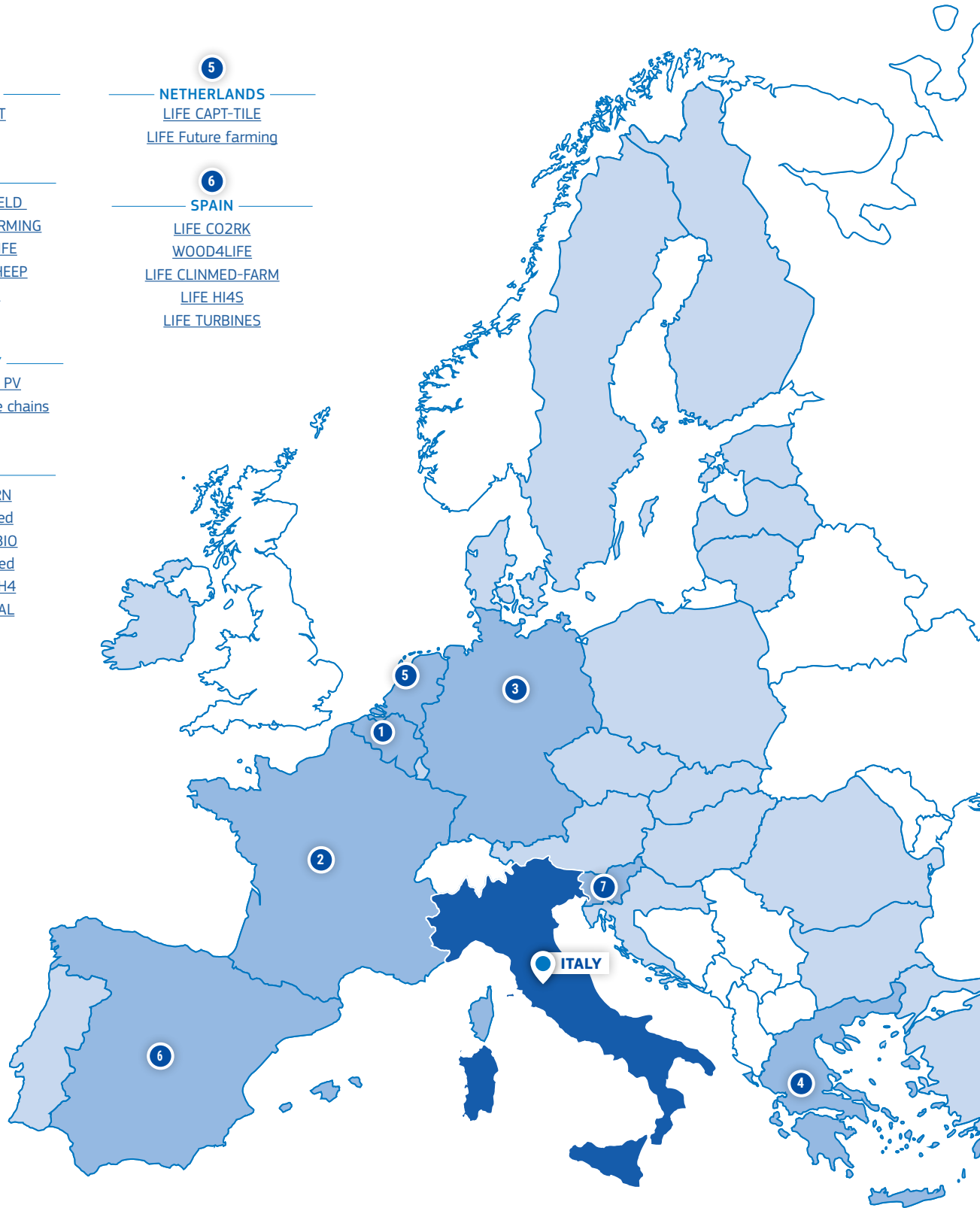

The LIFE Clean Energy Transition sub-programme supports the delivery of EU policies in the field of sustainable energy, in particular, the European Green Deal, the Energy Union (2030 energy and climate targets) and the European Union’s 2050 long-term decarbonisation strategy. It aims to facilitate the transition towards an energy-efficient, renewable energy-based, climate-neutral and -resilient economy by funding actions of high EU added-value, which are targeted at breaking market barriers that hamper the transition to sustainable energy.

Upscaling of Community Based Energy Efficiency Retrofitting (Scaling Super-Heero)

> [Project summary](#)

Financing energy efficiency renovations in buildings is paramount for the green transition. The Scaling Super-Heero project seeks to enhance retrofitting of supermarkets via crowdlending and reward campaigns. The interplay of engaged shoppers, citizens and communities with project developers and supermarket beneficiaries brings brand loyalty and social impact together by enabling the former actors to directly fund energy efficiency measures in shops. The crowdlending platform allows both project developers to fuel businesses by providing new opportunities for energy efficiency retrofitting, while simultaneously offering investors new frontiers for direct financial benefits. The overall spirit of the project rests on widening the sense of community with an eye to sustainable and environmentally conscious practices.

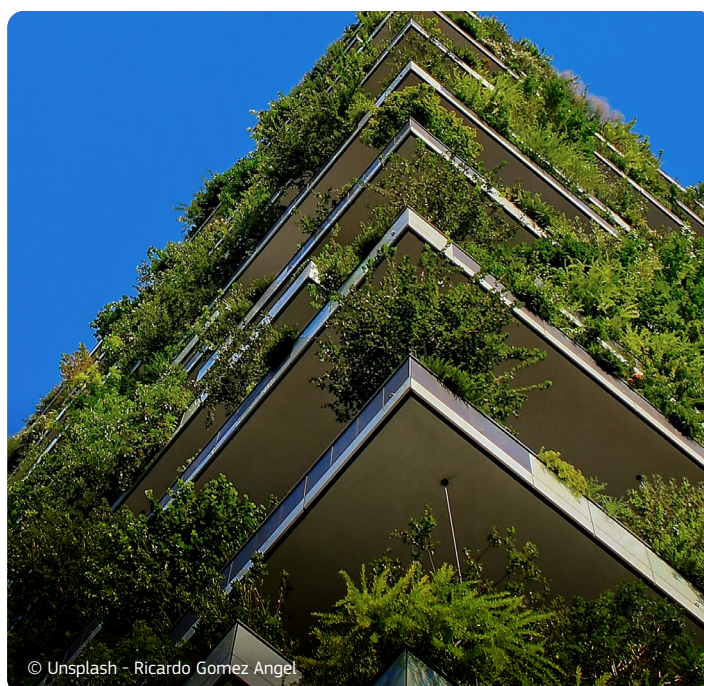

Examples of ongoing projects in Italy

The supply chains of the dairy sector are in desperate need of energy efficient practices to enhance their sustainability. **BETTED** addresses such conditions by way of fostering market uptake of energy efficiency measures including the use of renewables and the deployment of heat pumps at the value chain level in small and medium enterprises. To achieve this integration, the project seeks to implement capacity-building programmes to influence energy saving measures, increases in the share of renewable energy sources and heat pumps adoption investments with supporting tools.

Reductions in the emissions from building stocks are among the targets to achieve in the EU, which is pursuing the objective of doubling renovation rates by 2030. **ReLife** aims to facilitate data accessibility through an open-source platform and services to empower informed decision-making in building renovations, mainly in the residential sector. This platform will provide advice on financial and economic assessments for renovations, will help in generating projections for future renovation rates and decarbonisation scenarios and will support fine-tuning of categorisation standards deployed for energy efficiency inspections and certifications.

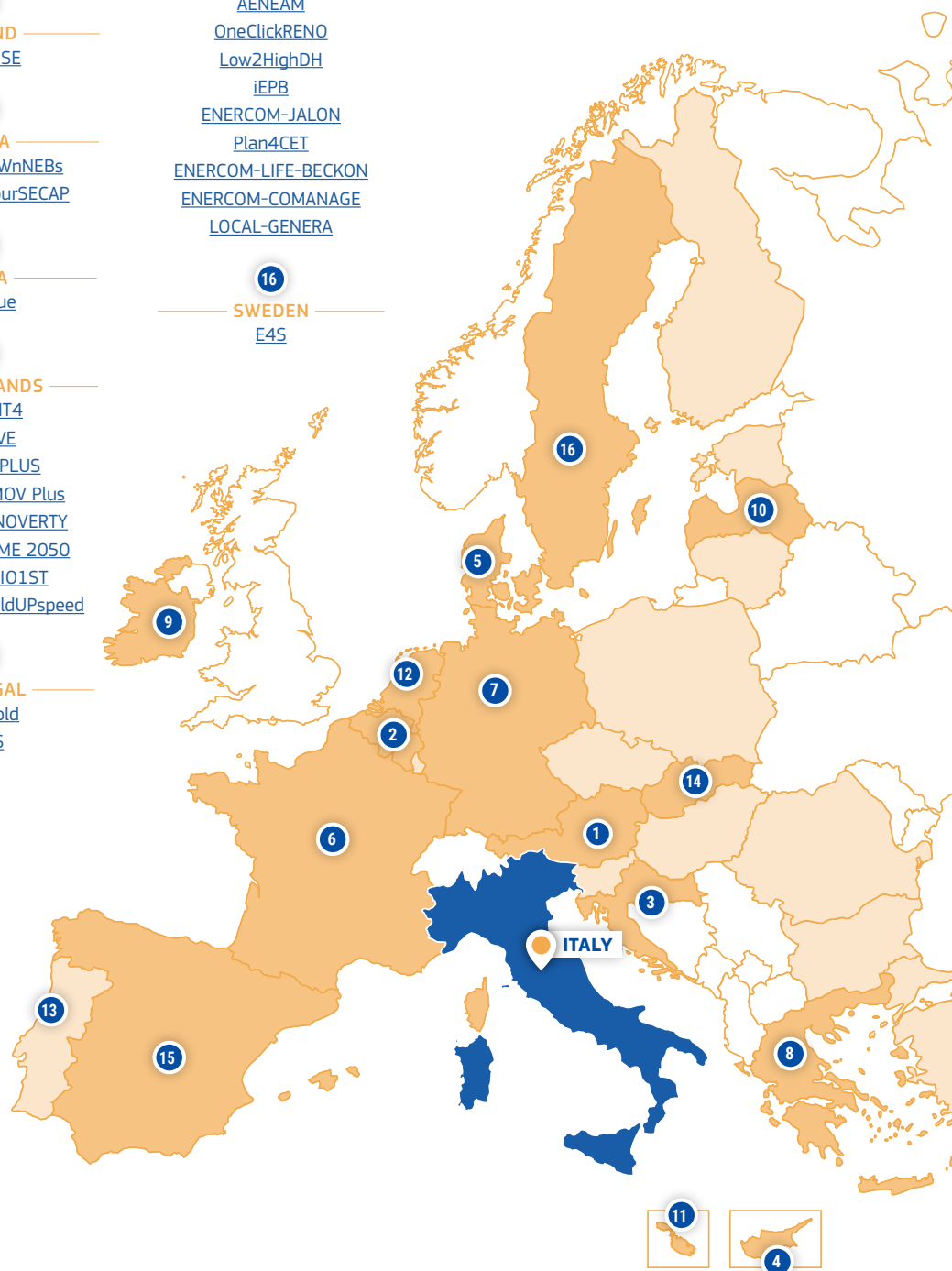
