What is **GREEN ASSIST**?

GREEN ASSIST is a new advisory initiative delivered under InvestEU, with funding from the LIFE programme. It aims to provide **free, on-demand and customised** advisory services to project promoters who develop green investment projects in environmental or non-environmental sectors.

There are many benefits to becoming a GREEN ASSIST expert. Joining the Roster will allow you to:



CONTRIBUTE: Play a role in the implementation of the European Green Deal.



ADVISE: Gain recognition of your expertise through participation in an ambitious advisory initiative through InvestEU.



PARTICIPATE: Engage in challenging assignments where you will help project promoters transform their ideas into real projects for a competitive remuneration.



LEARN: Acquire new knowledge of the European Green Deal objectives/trends.

In addition, you will become part of the GREEN ASSIST community of experts, giving you the opportunity to participate in training and knowledge-sharing activities with peers and representatives from EU institutions. You will also have access to the expert helpdesk to get support and share ideas within the community.

What does it take to be a GA expert?

GREEN ASSIST is flexible about the experience and expertise needed to join the Roster. However, there are some criteria that need to be met to ensure you have the relevant competencies to support GREEN ASSIST advisory services.

To be added to the Roster, you should have:

1 A master's degree in a relevant field (economics, environmental sciences, finance, engineering, etc.).

2 Proficiency in English (at least C1 level).

3 At least four years of experience in one or more of the fields listed below.
