








LIFE Funding opportunities for blue economy

- 1992-2020: > 5000 LIFE projects **focus** on Nature, Environment and Climate
- On marine environment LIFE funds a wide spectrum of projects, covering all three strands





LIFE Funding opportunities

- Four subprogrammes:
 - LIFE Nature & Biodiversity
 - LIFE Circular Economy and Quality of life
 - LIFE Climate Action
 - LIFE Clean Energy Transition



 LIFE applicants can make use of broad range of tools; from innovative projects, to best-practice, implementing concrete conservation actions, improving governance, and awareness raising.





LIFE Funding opportunities

- LIFE offers flexible funding options; from small/focused projects (usually under 5 M€) to large national/regional strategic projects (usually > 10 M€).
 60% co-financing. Call 2023 budget: 611 million €
- LIFE allows projects with diverse stakeholders; from single to multi beneficiary projects, involving authorities, industry, academia, NGOs, etc.

Call for proposals are open! 18 April and 11 May 2023,

- SIP Circular Economy/Climate Action DDL for submission 5 and 21 September 2023
- NatureBiodiversity/Circular Economy/Climate Action DDL for submission 6 Sep 2023
- Clean Energy Transition DDL for submission 16 November 2023
