ERTMS

- ERTMS-unit cost: Would it be possible to give a clear specification of urban nodes?
- Multiple configurations of the rolling stock can require multiple prototyping.
 Depending on how many wagons and where locos are being put, can you confirm that these need to go through dedicated prototyping processes?
- If we have previously received funding for prototypes, can we ask for funding for serial deployment?



ERTMS

 Can a single project request CEF support for ERTMS deployment on a number of different vehicle types (prototypes and/or serial) to be deployed with ERTMS Baseline 3 by different system suppliers?



Rail Interoperability

 Would studies and/or works for the implementation of the Automatic Train Operation (ATO) systems be eligible for funding under the topic "Removing rail interoperability barriers" (REMIB)?

 In the REMIB topic, would projects focused on harmonizing data exchange of both static and dynamic travel & traffic data for public transport be eligible?

 What does 'clean transshipment equipment for intermodal loading units' mean? Is this referring to cranes and reach stackers? What does 'clean' mean in this case?

Eligibility of participants

Are applicants / partners from Ukraine or Moldova eligible?

Are applicants / partners from other third countries eligible?

Can private entities apply for CEF funding?



Proposals

What is the minimum EU contribution for a project?

 Under CEF Transport, can project proposals for transport infrastructure include biodiversity elements as mitigating measures of the works?



Cost eligibility

 Can works carried out before the date of proposal submission but accepted (by the applicant) after this date be eligible?

 Can works where the contract was awarded before the signature of grant agreement, but implemented during the grant implementation period, be eligible?



Design and Build Contracts

• I intend to implement design & build procurement. Would it be possible to apply for only the study component?

 For works proposals only, are design elements (as part of a design and build contract) eligible?



CBA

 My project is being implemented in two locations. Can I submit two separate CBAs, or should I submit one single CBA report including all activities?



Maturity

 For an application relating to works, what are the chances of success if I have not yet obtained the development consent / building permit?
